## -----NOTES-----

1. *Visitor and temporary resident visa holders are currently not eligible to enrol in the Conservatorium High School, selective high schools Including agricultural high schools, the selective component of comprehensive high schools and Opportunity C (OC) classes in primary schools.*
2. *Enrolment of Visitor visa holders and out of local area placement is at the discretion of the school principal.*
3. *Intensive English as a second Language (ESL) provision includes support under the ESL/New arrivals program in schools and Intensive English Language Centres. Enrolment in Intensive English Language Centres is subject to specific enrolment conditions. If a visa is subject to visa conditions limiting study to a maximum of 3 months or the visa indicates a length of say of 3 months or less, a student cannot access intensive ESL support.*
4. *Exemptions in specific circumstances –*
  - *Temporary residents enrolled in a NSW government school prior to 1 July 2000 and subsequently continuously enrolled are exempt from payment of the temporary visa holder's fees.*
  - *Students on a recognized secondary student exchange program are exempt from payment of the temporary visa holder's fees.*
  - *School aged dependents of teachers on exchange programs organized by the NSW Department of Education and Training or arranged by an overseas coordinating teacher exchange organisations recognised by the Department in Memoranda of Understanding or Agreements are exempt from payment of the temporary visa holders fees.*
  - *Students whilst enrolled in a NSW Government hospital school and receiving in patient care are exempt from payment of the temporary visa holder's fees. Conditions of the visa held still apply.*
5. *NSW Ministry of Transport policy provides that visitor and temporary resident visa holders are no entitled to the school student transport subsidy unless exempt from payment of the temporary visa holders fees in a NSW government school because of the visa sub class held or exempted from the fees by an Exemption Review Panel based on capacity to pay.*
6. *The enrolment of international school students (visa sub class 571P) in NSW high schools is subject to specific enrolment conditions. Enrolment of primary school aged international students are only accepted and where a parent resides with the student Applicants must apply direct to the International Students Centre, Department of Education and Training on Telephone +61 2 917 4801 or 1300 302 456 (Australia only).*
